The Cooperator agrees to the following management activities:

- On the contracted areas, the Cooperator further agrees:
 - To protect all habitat from harmful unauthorized activities, such as grazing, haying, chemical application and mowing. This includes shredding the cover during the first year of establishment unless that activity is specifically approved;
 - To retain both the seeded and volunteer plants that are an important component of the program for wildlife and to limit herbicide and pesticide use to control noxious weeds in accordance with Nebraska statues except as authorized by a NGPC or PF representative;
 - To permit NGPC and PF representatives access to the property and USDA contract information necessary for inspection and annual payment purposes;
 - That renters or lessees of property may only enter into agreements if such rights are granted by the owner or with owner consent;
 - To allow access for all types of monitoring efforts for the program purpose;
- Either party, upon 30 days written notice, may terminate the contract; a pro-rata payment will follow.
- Modification to this contract must be made in writing and signed by the Cooperator, NGPC and PF representative.
- Program payments will be made after work is completed and bills are submitted to the Farm Service Agency and PF.
- If the Cooperator chooses to use a contractor, the Cooperator must assign USDA cost share payments for the work to PF.
- If Focus On Pheasants program funds are discontinued, NGPC and PF may void this contract.
- Failure on the part of the Cooperator to comply with the terms of this Contract shall be cause for contract cancellation and refund of program payments issued.
- Two Focus On Pheasants cooperator signs are required to be posted on lands enrolled under this contract.
- This writing and its attachments contain all the agreements between the parties.
